ELIGIBILITY GUIDELINES

Bevill State Community College 2018-2019

DUAL CREDIT:

- Students must be in the 10th, 11th, or 12th grade for Dual Enrollment credit
- Students must take state-approved college placement test for college-level English, Speech, and Math
- **Academic students** must have a minimum cumulative (unweighted) grade point average of 2.5 on a 4.0 scale for Dual Enrollment Credit
- Career technical education students must have a minimum cumulative (unweighted) grade point average of 2.0 on a 4.0 scale for Dual Enrollment Credit
- To maintain continuous eligibility, student must earn a "C" or better in all attempted college courses. Students who fail to meet this minimum GPA or withdraw from a course will be suspended from the program for a minimum of one term. The one-term suspension may not be served during the summer term.

ACCELERATED CREDIT:

- The student has successfully completed the 10th grade or has an exception granted by the participating postsecondary institution upon the recommendation of the student's principal and superintendent and in accordance with Alabama Administrative Code 290-8-9.17 regarding gifted and talented students;
- The student provides certification from the local principal or counselor certifying that the student has a minimum cumulative 3.0 GPA average and recommending the student be admitted under this policy;
- The student is enrolling <u>only</u> in postsecondary courses for which high school prerequisites have been completed (e.g., a student may not take English Composition until all required high school English courses have been completed).

Provide approved ID documentation. Request a copy of your official transcript from high school and any college(s) you have previously attended. If you received a GED, request your official GED transcript through GED Testing Services online. ☐ To be considered for most types of financial assistance, you must first complete the FREE APPLICATION FOR FEDERAL STUDENT AID (FAFSA) which is available online at www.fafsa.ed.gov. Bevill State's Financial Aid Code is 005733. ☐ Verification of Selective Service Registration for all male students between the ages of 18-26. If you have not registered with the Selective Service, please register at www.sss.gov. Once you have been admitted to Bevill State, you may view your awards or records required to complete your Financial Aid and/or Admissions Record at www.bscc.edu -MyBSCC. Your login is your student number and your default password is your date of birth in mmddyy format. ☐ Schedule an appointment with the Testing Center to take the placement exam. (If you have taken the ACT test, you may be exempt from the placement exam. Be sure to ask about ACT exemption requirements.) After you complete the the placement exam, you will be assigned an academic advisor. ☐ Contact your academic advisor. Your advisor will answer any questions you may have about your chosen program of study, review a degree plan, and assist you with registration for the upcoming semester.
